

NOTES TO THE APPLICANTS APPLYING FOR AUDIT LICENSE

Audit Licencing Requirement

Members are hereby informed that effective 1st January 2006 the Ministry of Finance has further amended the audit licensing requirements. The new requirements are as follows:-

1. Applicants must possess three (3) years of continuous relevant and sufficient audit experience; and
2. Applicants must have attended the Public Practice Programme organised by the Institute prior to the submission of the application.

For applicants who possess the relevant audit experience but are no longer in the audit field, at the point of submission, he/she must :-

1. Possess three (3) years of continuous audit experience in the time period of four (4) years before submission of the application; and
2. Have attended the Public Practice Programme organised by the Institute.

The three (3) years of continuous experience as mentioned above must be post membership of the Institute. The existing requirements to apply for the audit licence whereby applicants must be members of the Institute registered as a “Chartered Accountant” and applicants must hold valid practising certificate as a “Chartered Accountant” still remains.

NEW AUDIT LICENSE (BORANG A)

1. Applicant for audit license must be completed in **6 sets** with original signatures and photos on all the forms.
2. Applicant must also submit 6 sets of Certified True Copy of all the relevant certificates as well as the valid Practising Certificate.
3. Processing of audit license takes about 2-4 months. The Accountant General's Department will inform applicants 2 weeks prior to the interview.
4. The sponsor letter must be from an accountant holding a valid practising certificate and an audit license which is still in force.
5. The original letter from the referee should be in sealed envelope attention to the Accountant General's Department. The balance 5 sets can be photocopied and certified true copy by any MIA members provided that they stated their MIA membership number. Referee should not be the immediate family members.
6. Initial approval in principle letter will be issued to successful applicants within 14 working days from the date of the interview.

7. Payment of RM100/- payable to “**AKAUNTAN NEGARA MALAYSIA**” is to be paid after passing the interview, upon receiving the approval in principal letter together with Form 5 which certified by Suruhanjaya Syarikat Malaysia.
8. Applicant must set up the firm within 6 months upon receiving the principal approval letter otherwise the approval will lapse. If applicant is attending to join an existing partnership, he has to do so within 3 months.

NB: The statutory declaration forms must be original for all the 6 sets.
