PERSIDANGAN AKAUNTAN ANTARABANGSA MIA (MIA CONFERENCE) 2018

- Tema Persidangan** : *Riding the Digital Wave, Leading Transformation*

Bertemakan '*Riding the Digital Wave, Leading Transformation*', persidangan ini dianjurkan bagi menawarkan para akauntan pendekatan yang lebih mendalam bagaimana untuk memulakan inisiatif transformasi dan menggunakan kaedah yang tepat dalam memimpin organisasi ke puncak tertinggi. 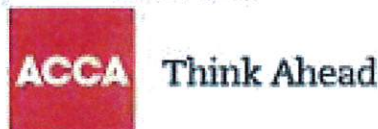

About the Organiser - MIA

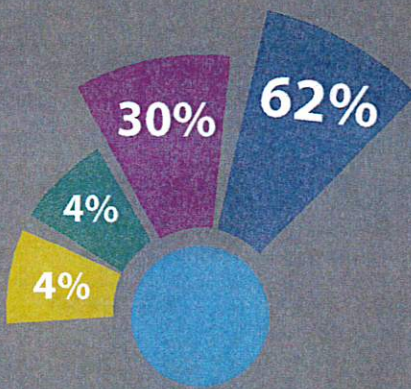

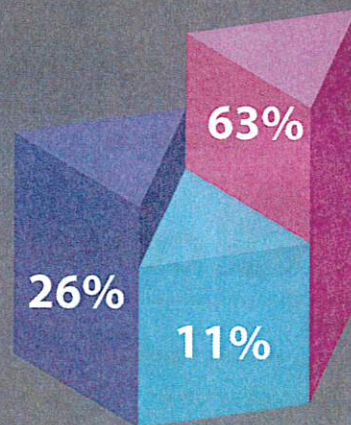

Number of delegates and sectors represented



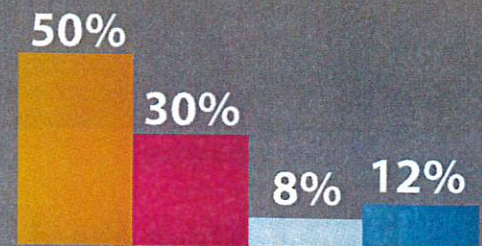
